

# AHA Committees Implement Strategic Plan

The success or failure of any organization begins and ends with the professional relationship between elected board leaders and staff. High-quality organization governance and program execution is a result from a solid working relationship among leaders.

The American Hereford Association (AHA) has been extremely blessed to have very sound business minds and industry people elected to the Board over the years to oversee the development and execution of a strategic plan, which has proven to pay dividends for the Hereford breed in recent years.

AHA has a committee structure established with specific roles that address the strategic plan of the organization. The following is a breakdown of committee purpose and responsibilities as well as the current director appointments for those for 2015:

## **Executive committee**

The role of this committee is to make urgent decisions on behalf of the Board when it's impossible for a Board quorum to be present. The executive committee rarely meets outside of the full Board and is principally responsible for communicating the performance review of the executive vice president and staff.

## **Financial/audit committee**

## **Breed improvement committee**

The principal purpose of any seedstock organization is to generate accurate selection decision information for purposes of improving the breed across a menu of economic relevant traits and indexes. This committee oversees the Pan-American Cattle Evaluation (PACE), genomic research projects, new economic trait development and industry-wide research involving Hereford genetics.

## **Marketing committee**

CHB LLC is a not-for-profit subsidiary and AHA's flagship branded beef program. Through licensing

agreements with packers and processors, CHB LLC generates royalty revenue used to fund the work of beef merchandisers, supply chain personnel, and consumer promotion and education activities with the purpose of driving demand for Hereford-influenced feeder cattle.
